APRIL-JUNE 2024 - Official Rules

1. PARTICIPATION BY CUSTOMERS OF ESTABLISHMENTS IN THIS PROMOTION IS FREE. NO PURCHASE IS NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.

2. PROMOTION OVERVIEW: The Red Carpet Rewards “Patio Paradise” Promotion (the “Promotion”) is sponsored by Illinois Gaming Investors, LLC d/b/a Prairie State Gaming (“Prairie State Gaming”) (“Sponsor”). The Promotion will be available at participating Prairie State Gaming locations within the State of Illinois.

Patrons will earn entries from Thursday, April 11, 2024 beginning at 12:01 pm, to Wednesday, June 19, 2024 at 12:00 noon. Earned entries will be accumulated and managed by the Red Carpet Rewards portal and all winners from this promotion will be determined by a random number formula in Excel. Patrons may earn entries at more than one of the participating locations. Patrons must earn entries the week of each \$200 drawing to qualify. The \$1,000 winners, Ford vehicle winner and prize package winners will be chosen from all entry earners throughout the entire promotional period.

On the following dates (April 18th, 25th, May 2nd, 9th, 16th, 23rd, 27th, 30th, June 6th, 13th and 19th), at noon, the Red Carpet Rewards portal/Excel will execute scheduled drawings and winners/a winner will be determined for all locations. The winners will be announced at 7:00pm each drawing day:

- Thursday, May 2nd – One winner of a Ford Vehicle Lease or cash alternative

- Thursday, June 6th – Seven winners of \$200 cash each
- Thursday, June 13th – Seven winners of \$200 cash each
- Wednesday, June 19th – Ten winners of \$1,000 cash each

- Also, Prairie State Gaming will donate up to \$5,000 per month with respect to each of April, May, and June 2024 (for a maximum amount of \$15,000) to either American Red Cross, American Cancer Society, ASPCA or Folds of Honor. The total monthly donation amount will be based on a monthly goal of check-ins on the Red Carpet Rewards app. The monthly totals will be calculated by the total check-ins from the 1st of each month through the last day of each month, and will be paid retrospectively, after the end of the second Quarter of 2024.

- Additionally, there will be Hot Seat drawings that will award the winners a \$100 Home Depot gift card. The drawings will be executed on Sundays (April 14th, 21st, 28th, May 5th, 12th, 19th, 26th, June 2nd, 9th and 16th) at 1:00pm, using a random number formula in Excel. These Hot Seat drawings are open for all valid entry earners during the Patio Paradise promotion. Patrons must be checked-in to a participating location at 1:00pm on each drawing day for their chance to win. Three winners will be selected each drawing day. One winner will be awarded by entries earned in locations assigned to our Rockford and Chicago routes, one winner will be awarded by entries earned in locations assigned to our Quad Cities and Bloomington routes, and one winner will be awarded by entries earned in locations assigned to our Springfield, Effingham and Alton routes. Winners of the hot seat drawing will be announced the following Monday morning.

The \$200 prizes will be awarded in the form of cash. The \$1,000 prizes will be issued by check and may be subject to withholding and other regulatory requirements. The Ford Vehicle prize will be awarded in the form of a check from Prairie State Gaming for up to \$25,000 directly to the dealership if the vehicle lease is chosen or in the form of a check for \$15,000 directly to the winner if the cash prize option is chosen. Ford vehicle lease is for 2 years and up to \$25,000. The winner's choice of vehicle and qualifying credit will determine the final lease payout amount provided by Prairie State Gaming.

Entry multiplier dates: All participants are eligible for the entry multiplier days, which are Mondays, April 15th through June 17th, 2024 at a 2x multiplier and Fridays, April 12th, 2024 through June 14th, 2024 at a 5x multiplier.

3. HOW TO PLAY: Patrons at each of the participating locations must download and activate the Red Carpet Rewards App on their smartphone from either the App Store or Google Play. Upon entering a participating location, the patron must either log into or ensure they're logged into the Red Carpet Rewards App to earn entries. No gaming play is required for this promotion, as patrons earn when they have the Red Carpet Rewards App active and functioning at a participating location. Entries are earned and accumulated based on time in the location itself and no other consideration is given. An alternate method of entry via mail, may also be used (see official rules for details).

It is the patron's responsibility to have the following:

- a) A properly functioning smartphone updated to current versions of related operating systems and of the Red Carpet Rewards App itself.
- b) That they have logged in and have the Red Carpet Rewards App running in the foreground.
- c) That both cellular data and Bluetooth is activated and functioning properly.

Any attempt to defraud or earn entries by fraudulent means will be disqualified. Management of Prairie State Gaming reserves the right to review all entries for such activity and to adjust entries accordingly.

4. ELIGIBILITY: The promotion is open to all guests who are twenty-one (21)

years of age or older at the time of entry. No purchase necessary. Officers, directors, managers, owners of and employees of participating locations and Prairie State Gaming, and each of their respective parents, subsidiaries, affiliates and related companies, as well as immediate family members and/or those living in the same household of each such person, and any others engaged in the development, production, execution or distribution of this giveaway, are not eligible to participate. Additionally, any persons who assist any location as unpaid or volunteer personnel are excluded from participating.

5. PARTICIPATION: To participate, eligible guests may visit a participating Prairie State Gaming / Red Carpet Rewards location.

- Additionally, there will be Hot Seat drawings that will award the winners a \$100 Home Depot gift card.

The drawings for the seven \$200 cash winners will be split geographically by PSG's route offices. One winner will be awarded by entries earned in locations assigned to our Rockford, Quad Cities, Chicago, Springfield, Bloomington, Effingham and Alton routes. The drawings for the ten \$1,000 cash winners will be split geographically by PSG's North, Central and South regions. Three \$1,000 winners will be awarded by entries earned in locations assigned to our Rockford and Chicago routes, four \$1,000 winners will be awarded by entries earned in locations assigned to our Quad Cities and Bloomington routes and three \$1,000 winners will be awarded by entries assigned to our Springfield, Effingham and Alton routes.

7. WINNERS: Except for the Hot Seat drawings, winners do not need to be present to win. To claim their prize, winners must contact Prairie State Gaming at 630-870-3400 and provide ID verification to prove identity or by contacting the stated vendor for the individual location prizes as provided in the winner's notification sent directly to each winner.

Winners will be contacted by the following means:

- a) Direct messaging through the App by the Red Carpet Rewards portal, and/or
- b) Direct email through the Red Carpet Rewards portal to the email address stored in patron data within the portal, and/or
- c) By phone through the phone number store in the Red Carpet Rewards portal.

If after 14 days from the date of winning the winner of a state-wide drawing cannot be contacted by the above means, the prize is forfeited and an alternate will not be drawn. Additionally, Prairie State Gaming reserves the right to redraw for an eligible winner should it be verified that someone whose name is drawn is not eligible based on factors stated in Paragraph 4.

8. CONDITIONS: Any and all applicable taxes on Gifts/Prizes which are awarded in this Promotion are the sole responsibility of the winners. Entries are nontransferable. Sponsor is not responsible for lost, late, misdirected, incomplete, damaged or ineligible entries. No copies or reproductions allowed. By participating, each Participating Eligible Entrant agrees: (a) to abide by these Official Rules and decisions of Sponsor, which shall be final and binding in all respects relating to this Promotion; (b) to release, discharge and hold harmless

Sponsor and affiliated agencies or entities working on this Promotion, and each of their respective parents, affiliates, subsidiaries, and advertising and promotion agencies, and the respective officers, directors, shareholders, employees, agents and representatives of the forgoing (collectively, “Released Parties”) from any and all injuries, liability, losses and damages of any kind to persons, including death, or property resulting, in whole or in part, directly or indirectly, from entrant’s participation in the Promotion or any Promotion-related activity or the acceptance, possession, use or misuse of any Prize; (c) in the case of the daily drawings, the right to use such winner’s name, photograph, quote(s), and/or likeness for advertising, publicity and promotional purposes in any and all media, now or hereafter known, without limitation and without compensation other than the Prize awarded. By participating, entrant also agrees not to release any publicity or other materials on their own or through someone else regarding their participation in the Promotion without the prior consent of the Sponsor, which it may withhold in its sole discretion.

Additionally, Prairie State Gaming, Penn National Gaming, and the participating locations are not responsible for the following:

- a) Entries not recorded or earned due to not logging in to the Red Carpet Rewards App.
- b) Entries not recorded or earned due to issues with cellular data, Wi-Fi, or Bluetooth.
- c) Entries not recorded or earned due to issues with smart device functionality.
- d) Entries not recorded or earned due to swiping off the App, logging off the App, or deleting the App mid-session or otherwise.
- e) Entries not recorded or earned due to malfunctions of the following:
 - a. The beacon within the location.
 - b. The Red Carpet Rewards portal itself.

In the event that the Red Carpet Rewards portal notifies multiple persons via App or email notification as winners in error, management at Prairie State Gaming reserves the right to review the results and determine the actual winner. Additionally, should the Red Carpet Rewards portal fail to determine a winner(s), the management of Prairie State Gaming will determine a winner at random utilizing the entry data from the promotion.

9. MISCELLANEOUS: In the event of a discrepancy between these Official Rules and any creative/collateral materials relating to the Promotion, these Official Rules will prevail. Released Parties are not responsible for lost, late, incomplete, damaged, inaccurate, stolen, delayed, misdirected, undelivered, or damaged entries, or for lost, interrupted or unavailable network, server, Internet Service Provider (ISP), website, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Promotion, including, without limitation, errors or difficulties which may occur in connection with the administration of the Promotion, the notification of winners, or in any Promotion- related materials. No more than the advertised number of Prizes will be awarded. The odds of winning are dependent upon the number of entrants. Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by site users, tampering, hacking, or by any equipment or programming associated with or utilized in the Promotion. Released Parties are not responsible for injury or damage to any person's computer related to or resulting from participating in this Promotion. Persons who act in an unsportsmanlike or disruptive manner or who are in violation of these Official Rules, as solely determined by Sponsor, will be disqualified and all associated entries will be void. Sponsor reserves the right at its sole discretion to suspend, modify or terminate the Promotion (or portion thereof) for any or no reason, including if Sponsor determines that any portion of the Promotion is compromised for any reason, and, if terminated, at Sponsor's discretion, Sponsor may select the potential winner(s) for the drawing(s) at issue from among all non-suspect, eligible entries received for the applicable drawing(s) prior to action taken.
